# **HSIs: Back to the Basics**

- . What is an HSI?
- . Why should I care? / What does it have to do with me and my role?
- As a Research Administrator, how might I be a part of advancing HSI efforts?



Hispanic is a federally designated umbrella term to categorize and track numbers in a census fashion. ASU sees data as key to the intentional design work of expanding access and inclusion.

A community and its members use other terms to reflect their chosen language to express identity. Some of these terms include: Latino, Latinx, Afro-Latino, Mexican American, Central American, South American, Puerto Rican, Cuban, Boriqua, and Chicano. Because language is a creative form of communication, it reflects the evolving ways people and communities think about themselves, especially within ever-expansive contexts.

For example, the "x" in Latinx intends to signal intersectional identities and gender inclusivity (equivalent to the use of "their"). Whatever the term or identity, and ASU embraces them all, we recognize and celebrate the vibrant diversity within our university.




## What is a Hispanic Serving Institution?

- Federal designation by the Dept. of Education acknowledging higher education institutions that <u>enroll</u> at least 25% Hispanic students (IPEDs data)
  - <u>and</u> demonstrate a high concentration of students who are eligible for Pell Grants
- Must apply each year to receive designation
- Designation does not come with any guaranteed funding
- > HSIs eligible to apply to certain funding opportunities

- ✓ Enrolls 25%+ Latinx students,
- ✓ Produces equitable outcomes for Latinx students, and
- Enacts a culture that is educationally affirming, culturally responsive, and welcoming.

## **Beyond Enrolling:** Servingness

- Grants and research development / administration as a key tool in *serving* underrepresented students and communities
  - Allows the development, funding and administration of quality programs that increase academic success and wellbeing of our students
- Since UArizona was designated an HSI in 2018, HSII has directly supported proposal development resulting in \$81M in awarded projects

- 2. Minority Serving Institution (MSI) programs
  - only MSIs eligible to apply
- 3. Other equity focused programs

#### Table I. U.S. Department of Education HSI Grant Program Descriptions

#### Title V, Developing Hispanic-Serving Institutions

#### HSI STEM (Title III, Part F)

Promoting Postbaccalaureate Opportunities for Hispanic Americans (PPOHA) The purpose of this program is to enable HSIs to expand and enhance their academic offerings, program quality, and institutional stability by investing in scientific or laboratory equipment for teaching, infrastructure, faculty or curricular development, academic counseling programs, student support services, amongst others. Funds may be used toward faculty and curriculum development, academic support services, teacher education, among others.

The purpose of this program is to increase the number of Hispanic and other low-income students attaining degrees in the fields of science, technology, engineering, or mathematics; and to develop model transfer and articulation agreements between two-year and four-year institutions in such fields. Funds may be used toward STEM programmatic development, creating learning communities, improving STEM equipment, among others.

The purpose of this program is to expand postbaccalaureate educational opportunities for, and improve the academic attainment of, Hispanic students by investing in institutions of higher education that are educating the majority of Hispanic college students and helping large numbers of Hispanic and low-income students complete postsecondary degrees. Funds may be used toward outreach efforts to students who have completed their undergraduate degree, enhance existing post baccalaureate programs, or create new programs, among others.

Challenges	Strategies		
Decentralized structures and/or personnel for applying for federal grants	Integrating campus offices and staff into the grant process (formation to implementation)		
Difficulty acquiring institutional "buy-in" to sustain initiatives long-term	Incorporating institutionalization plans at the start of the grant writing process and creating institutional alignment		
Developing an "institution-wide HSI identity"	Engaging with external HSI organizations, federal HSI Grant funding, and enhancing HSI conversations at the leadership level		

#### Strategic Practices for HSI Grant Participation

- Align grant funding with institutional priorities to demonstrate need and push for sustainability at your institution.
- Lead and integrate campus wide to successfully apply and oversee HSI grants.
- Engage with external HSI organizations (e.g., HACU, Excelencia in Education)
- Promote HSI identity to act as a motivator for institutional level change
- Align efforts with strategic priorities that support Latine students



#### Strategic practices (Cont.)

- Expand educational opportunities for, and improve the academic attainment
- Enhance counseling and advising
- Student transition from high school to community college and postsecondary education
- Student transition into careers
- Increase outreach to Latinx students
- Expand professional development opportunities for BCC's Student Success Team, faculty, administrators and the community
